

NEWMARKET STUD FARMERS' ASSOCIATION CHECK LIST FOR DOCUMENTS WHICH MUST ACCOMPANY MARES WALKING-IN FOR COVERING – NH SEASON 2026

ALL MARES

- ☐ Passport or legible photocopy for every covering – **showing all vaccinations for Equine Influenza**
- ☐ Freedom from Infection Certificate (to be completed on the day of covering)

Select Mare and Covering type for correct check list

PLEASE NOTE: Mares who have received antibiotic treatment following a difficult foaling will require an additional clitoral swab as per Section C of the NSFA Breeding Regulations.

LOW RISK MARE from UK or Ireland

FIRST COVERING

- ☐ Clitoral swab (new)
- ☐ Endometrial/Cervical swab
- ☐ EIA x 1
- ☐ EVA x 1

REPEAT COVERING ON ANY SUBSEQUENT OESTRUS PERIOD

- ☐ Endometrial/Cervical swab

LOW RISK MARE from outside of UK or Ireland

FIRST COVERING

- ☐ Clitoral swab (new)
- ☐ Endometrial/Cervical swab
- ☐ EIA x 2 minimum
- ☐ EVA x 2
- ☐ EIA for foal – if arrived from Germany or Italy

REPEAT COVERING ON ANY SUBSEQUENT OESTRUS PERIOD

- ☐ Endometrial/Cervical swab
- ☐ EIA x 1 (new)

HIGH RISK MARE from UK or Ireland

FIRST COVERING

- ☐ Clitoral swab x 2
- ☐ Endometrial/Cervical swab (BEVA certificate) x 1
- ☐ EIA x 1
- ☐ EVA x 1

REPEAT COVERING ON ANY SUBSEQUENT OESTRUS PERIOD

- ☐ Endometrial/Cervical swab (new)

HIGH RISK MARE from outside of UK or Ireland

FIRST COVERING

- ☐ Clitoral swab x 2
- ☐ Endometrial/Cervical swab (BEVA certificate) x 1
- ☐ EIA x 2 minimum
- ☐ EVA x 2
- ☐ EIA for foal – if arrived from Germany or Italy

REPEAT COVERING ON ANY SUBSEQUENT OESTRUS PERIOD

- ☐ Endometrial/Cervical swab (new)
- ☐ EIA (new) x 1

CROSS COVERINGS (REPEAT COVERINGS IN SAME OESTRUS PERIOD) FOR HIGH OR LOW RISK MARES

- ☐ Passport or legible photocopy
- ☐ Freedom from Infection Certificate
